<p style="text-align: center;">Baby Born, Endowed</p>	<p style="text-align: center;">Cargo Berthed, Delivered</p>
<p>Your Mother autographs to establish that you are "holder of your Estate in due course"</p>	<p>Informant autographs as indictment that you have no paternal holder of your Estate</p>
<p>Mother gives maiden name. You are presumed to have no paternal Owner (bastard)</p>	<p>Registrar signs your Estate into Probate and you become a "Ward of the State"</p>
<p style="text-align: center;">Given a Lawful Name</p> <p>Your Given Name(s) Title is recorded, traditionally in a Family name bible</p>	<p style="text-align: center;">Name is Corporatised</p> <p>A legal Tradename is publicly registered, combining your Given and Family names</p>

<p style="text-align: center;">Rightful Beneficiary of the tradename</p>	<p style="text-align: center;">Unwitting Trustee of the tradename</p>

Later usage shows your title as unique ~ John: (of family name)</p>	<p style="text-align: center;">Format is either hand-written or typed, and not necessarily all-capitals, which is often later used to indicate the legal name</p>

Rights of liberty and citizenship unaltered.'</i> [Black's Law, 2nd Edition]</p>	<p style="text-align: center;"><i>'Capitis diminutio maxima. The highest or most comprehensive loss of status. Changed from one of freedom to one of bondage.'</i> [Black's Law, 2nd Edition]</p>
<p style="text-align: center;">SOVEREIGN PUBLIC TRUST</p> <p>At the age of 18 you can become Executor of your Estate as a free man/woman in your Sovereign Trust. As the "holder in due course", in a Permanent Trust, you can now at any time claim "Legal Title" to your Estate property</p>	<p style="text-align: center;">FOREIGN SITUS TRUST</p> <p>A Trust is formed by splitting your Estate, creating a "Legal Title" (holder) for the State, and an "Equity Title" (user) for you. As it is a Temporary not permanent Trust, you only have Beneficiary "use" not "Legal Title" of property</p>
<p style="text-align: center;">You are BENEFICIARY of SOVEREIGN PUBLIC TRUST</p> <p>State is your Public Servant/Trustee with a Fiduciary duty to protect and serve you, the rightful Beneficiary of your Public Trust</p>	<p style="text-align: center;">State is BENEFICIARY of FOREIGN SITUS TRUST</p> <p>State is Holder of your Estate (real property), used as a Surety for I.M.F. debt obligations, and is the Beneficiary of the Situs Trust</p>
<p style="text-align: center;">Born as Holder of Estate, Grantor</p>	<p style="text-align: center;">Berthed as User of Estate, Debtor</p>
<p>This Record is used as Evidence for a Birth Certificate that certifies a Bond issue</p>	<p>This Certificate is certification of a Bond with the World Bank as Settlor of the Trust</p>
<p>Includes your birth weight in ounces used to calculate value in tables related to gold</p>	<p>The settled Bond becomes a Security that is traded on the Market for your value</p>

<p>This document established your Estate, which can then be stolen. But it is also your Affidavit of Life and proof of claim</p>	<p>This document converts your Estate into a tradeable property and puts you to work for the Foreign Situs Trust via the "NAME"</p>
